

## V. SOLID WASTE FEE EXEMPTIONS

- A. A property owner who qualifies for hardship abatement from the Board of Assessors will be given a 25% discount toward the Solid Waste Fee, provided this property is their principal place of residence.
- B. A property owner may be exempted from the Solid Waste Fee provided s/he meets the following criteria:
  - 1. Produces documentation of a bona fide rubbish and recycling contract for a minimum of one (1) year, to be reviewed every six (6) months. One (1) contract per unit, unless multi-units are on one assessed lot as defined by the Assessors' office. The contract must stipulate that it covers the residency for which the exemption is being requested. No fee exemption will be considered or granted for a previous fiscal year.
  - 2. In the absence of a bona fide rubbish and recycling contract the property owner must provide a letter from the rubbish/recycling collection contractor, on the contractor's letterhead, stipulating that it covers the residency for which the exemption is being requested and when the services began. No fee exemption will be considered or granted for a previous fiscal year.
  - 3. The contract must contain a Federal Identification Number, and the rubbish contracting firms name must appear on the "Trash Haulers List" as published by the North Attleborough Board of Health.
  - 4. Property owners that transport their waste from the residence for which the exemption is being requested to another location within the Town of North Attleborough must provide the applicable documentation described in Section V.B., Item 1 or 2 and comply with Section V.B., Item 3.
  - 5. Property owners that transport their waste from the residence for which the exemption is being requested, to another location outside the boundaries of the Town of North Attleborough, must provide the applicable documentation described in V.B., Item 1 or 2 above.
  - 6. Any participant who owns more than one unit and can prove that one or more units have been vacant for the previous twelve months will receive a full abatement of the Solid Waste Fee for that unit for the fiscal year during which the application is made. Proof of such vacancy must be verified by submission of the most recent electrical bill, from NAED, showing that the unit in question received the minimum maintenance charge associated with services that do not use any power, for the previous twelve months.

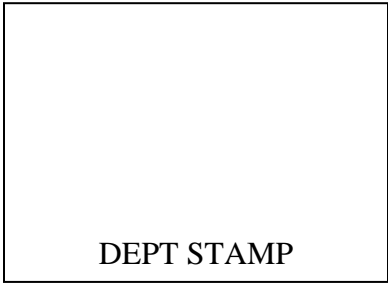
NOTE: Any property owner who requests and is approved for an exemption, will receive no Town services of curbside trash and recycling collection and access to the Recycling Center for the remainder of the fiscal year. The above exemption must be reapplied for annually.
